A Resolution of the Mayor and City Commission of the City of South Miami, Florida, relating to appropriations for the February 9, 2010 General and Special Elections for the City of South Miami; approving the total amount of \$23,168.68 for election costs; charging the election account no. 001-1200-512-4920; and providing an effective date.

WHEREAS, the FY 2009-2010 adopted budget provides the amount of \$25,000.00 for the February 9, 2010 General and Special Elections; and

WHEREAS, the total amount for the February 9, 2010 General and Special Elections is \$23,168.68.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF SOUTH MIAMI, FLORIDA;

Section 1: That the Finance Director is authorized to disburse the amount of \$23,168.68 from account No. 001-1200-512-4920 (City Clerk-Elections) with a current balance of \$23,932.93 to pay the Board of County Commissioners for the City of South Miami General and Special Elections held February 9, 2010.

Section 2: That one-percent assessment fees in the amount of \$1,000 for the eight running candidates was paid out of account no. 001-1200-512-4920 to the Florida Election Commission as per Florida Statutes 99.093.

Section 3: That the total amount of qualifying fees in the amount of \$1,800.00 collected from the eight running candidates was deposited in revenue account no. 001-0000-341-9020.

This resolution shall be effective upon approval.
