Live Remote Public Viewing

You can test your connection to Zoom by clicking on the following link: <http://zoom.us/test> Please make sure that your computer has a working speaker and, preferably, a working webcam so that you can hear and see and be seen on the City Hall monitors and by the other Zoom participants in the live streaming of the meeting. Some computers and/or smartphones have both features. Each virtual participant in the Zoom virtual meeting will be automatically muted upon joining the meeting and only the Chair may unmute an attendee.

Note that pursuant to Florida Statutes 286.0105, a person who decides to appeal any decision made by a Board, Agency or Commission with respect to any matter considered at its meeting or hearing, a record of the proceedings will be required for said appeal and such person will be required to have a verbatim transcript of the proceedings including the testimony and evidence upon which the appeal is to be based.
